MEETING MINUTES

The Board having reviewed the May 26, 2021 meeting minutes, said minutes were approved as submitted.

TREASURER'S REPORT

The May 31, 2021 Treasurer's report was presented by Art Heitlauf. Art reviewed the changes to the balances in the Checking, Capital Improvements, and Investment accounts. Membership continues to increase and compares very favorably to any similar club in the Northwest.

1. Roof Replacement Project Schedule

CR, AH, and MS met with Alejandro Vasquez (US Bank in Woodburn) to update the club records and signing authorities. A loan application was completed and is pending.

4. Fund Raising Report

Art Heitlauf reported that there is approximately \$26,000 in donations (pledged and received) as of yesterday. Very good progress on this fundraising effort.

OPERATOR'S REPORT

Dave Fiedler presented the Operator's Report. The following items were discussed:

- 1. The High School teams have a tournament coming up in Hillsboro.
- 2. SuperSport Showdown this weekend. It will be warm. Dave and Vandy have stocked up on ice, water, and Gatorade to keep all the shooters hydrated.
- 3. Ammunition continues to flow slow but steady. Dave continues to supply some of the surrounding clubs as possible.
- 4. Vandy noted that about 65 shooters are signed up for the tournament this weekend. Dave is preparing to have as many stands as possible located in shady spots.

It is a credit to the "Operators", that the club has remained open throughout the pandemic, ammunition continues to be available, and our membership is the highest in history. Thanks to Dave and Vandy!
